

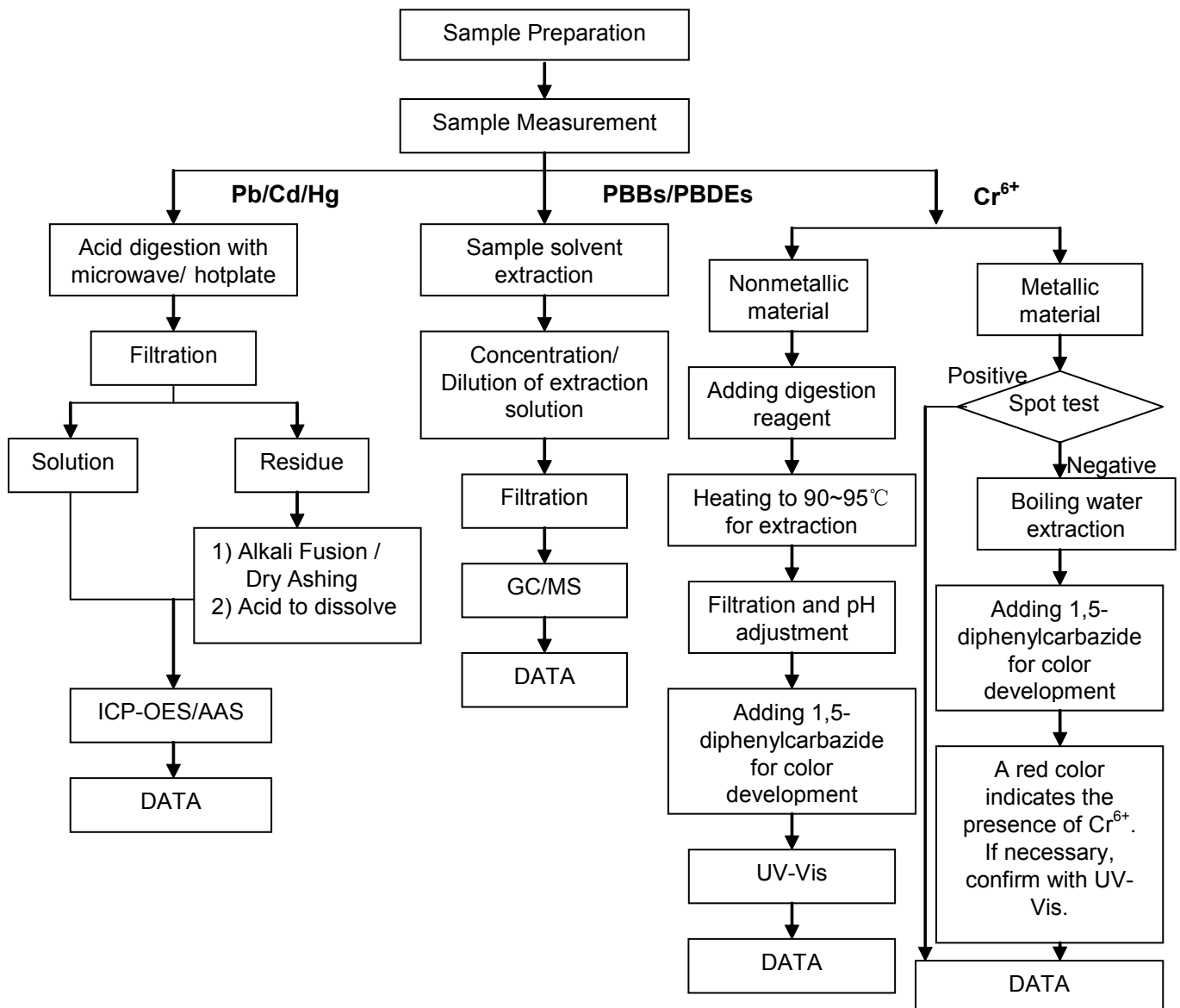

RoHS Testing Flow Chart

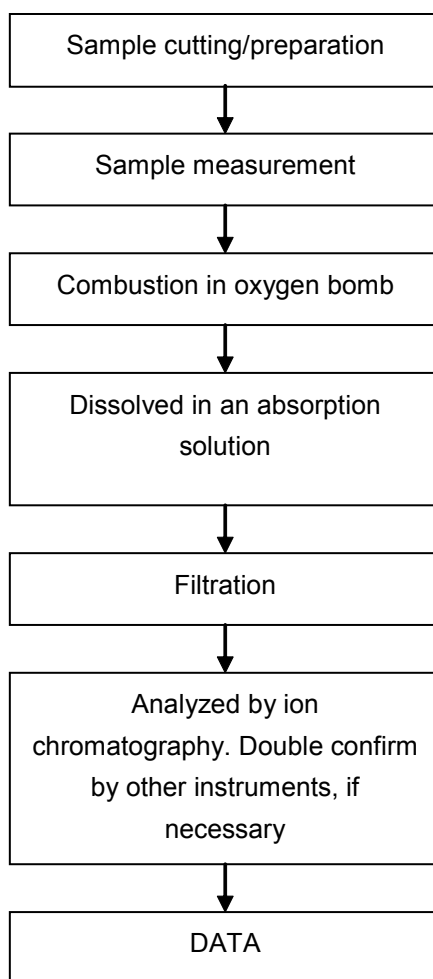
